POLICY ON PRESERVATION OF DOCUMENTS AND ARCHIVAL OF DOCUMENTS IN THE WEBSITE

[Under Regulation 9 and 30(8) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015]

1. PURPOSE ANDSCOPE

- 1.1 The purpose of this document is to present a policy statement for Gradiente Infotainment Limited (Company) regarding preservation of its documents and archivalofdocumentsinthewebsiteinaccordancewiththeprovisions of the Companies Act, 2013 and Regulation 9 and 30(8) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015("LODR").
- The policy is framed for the purpose of systematic identification, categorization, maintenance, review, retention and destruction of documents received or created in the course of business. The policy gives guidelines on how to identify documents that need to be maintained, how long certain documents should be retained, how and when those documents should be disposed of, if no longer needed and how the documents should be accessed and retrieved when they are needed.

2. CLASSIFICATION OF DOCUMENTS TO BE PRESERVED / RETAINED

- 2.1 The Company's physical and electronic documents shall be classified for the purpose of preservation asfollows:
 - A. Documents whose preservation shall be permanent innature;
 - B. Documents whose preservation period shall not be less than eight years after completion of the relevanttransactions;
 - C. Documents whose preservation shall be for a minimum period of three years after completion of theevent.

The details of documents for the above three categories are given in the Annexure.

3. PRINCIPLE OF RESPONSIBILITY OF EMPLOYEES FOR PRESERVATION OF DOCUMENTS

3.1 All the Employees in the permanent rolls of the Company are responsible for taking into account the potential impacts on preservation of the documents in their work area and their decision to retain/preserve or destroy documents pertaining to their area.

4. PERIODICAL REVIEW OF THEPOLICY

4.1 The Whole-time Director/ Managing Director of the Company is authorized to periodically review the policy and make such changes as considerednecessary.

5. SUSPENSION OF RECORD DISPOSAL IN THE EVENT OF LITIGATION OR CLAIMS

5.1 In case the Company is served with any notice for request of documents oranyemployeebecomesawareofagovernmentalinvestigationoraudit concerning the Company or commencement of any litigation against the Company, any further disposal of documents connected with the matter shall be suspended until such time the investigation / litigationends.

6. STATUTORYREQUIREMENTS

6.1 If as per any other law of land including Information Technology Act, a physicalorelectronic records hould be preserved for along er period than what has been stipulated in this policy, then the document shall be preserved as per the applicable statutory stipulations.

7. WEB ARCHIVALPOLICY

- 7.1 TheCompanyshalldiscloseonitswebsitealleventsorinformationwhich has been disclosed to stockexchange(s).
- 7.2 Such disclosures shall be retained on the website of the Company for a minimum period of fiveyears.
- 7.3 At the end of the fifth year the information shall be archived and preserved for a further period of threeyears.

- A. Documents whose preservation shall be permanent innature:
- 1. Property records including purchase and sale deeds, licenses, copyrights, patents & trademarks
- Corporate Records including Certificate of Incorporation, Common Seal, Minutes of Board, Committee and Shareholders' Meetings, Register of Members and other Statutory Records
- 3. Personal files of all live employees
- 4. Any other record as may be decided by the Whole-time Director of the Company from time totime.
- **B.** Documents whose preservation period shall not be less than eight years after completion of the relevanttransactions(but need to be preserved in electronic form permanently):
- 1. Books of Accounts, Bank Statements andvouchers
- 2. Filings with Stock Exchanges, Registrar of Companies and other statutoryauthorities.
- 3. Payroll Records, Employee deduction authorizations, attendance records, employee medical records, leave records, Pension and retiral related Records, etc.
- 4. Corporate Social ResponsibilityRecords
- 5. Sponsorship ProjectsRecords
- 6. Correspondence and InternalMemoranda
- 7. Any other record as may be decided by the WTD of the Company from time totime.
- C. Documents whose preservation shall be for a minimum period of three years after completion of the event (but need to be preserved in electronic form permanently):
- 1. TenderDocuments
- 2. Lease Deeds and Contracts
- 3. Legalfiles
- 4. Insurance Records including policies and claims
- 5. All e-mail correspondence, internal & external
- 6. Documents under Secretarial Standards
 - $6.1\,$ Proof of sending Notice of the meetings of the Board / Committee and General meetings and its delivery
 - 6.2 Proof of sending Agenda and Notes on Agenda and theirdelivery
 - 6.3 Proof of sending and delivery of the draft of the Resolution
 - 6.4 Proof of sending draft Minutes and itsdelivery
 - 6.5 Proof of sending signed Minutes and itsdelivery
- 7. Any other record as may be decided by the Chief Executive Officer of the Company from time totime.

Amendments to the policy:

Any amendments or modifications thereon, as may be required from time to time, in the policy shall be approved by the Board of Directors and shall have effect from the date of such amendment.
